Prize Terms and Conditions

Australian Events Marketing Pty Ltd (ABN 86 622 976 087), often called "Australian Events" is the promoter of this competition and hereafter in the terms and conditions will be referred to as the "Promoter".

Information on how to enter and the prize to be won form part of the terms and conditions.

By entering this competition, you confirm that you have read and understood these terms and conditions and agree to them.

There is one (1) prize. The prize consists of an Altec patio, carport, enclosure and/or outdoor blind project selected from Altec's standard product range, including design, approvals, supply and installation. 6. The winner will be notified from a representative of Altec by phone and email. Altec may attempt contact up to ten (10) times by phone and ten (10) times by email over a period of ten (10) business days. The winner must respond and accept the Prize by 31 October 2026.

 - b. Without limitation, Altec may determine that a site is unsuitable where: significant retaining walls are required; substantial earthworks or excavation are required; demolition works are required; asbestos removal is required; substantial drainage works are required; significant electrical upgrades are required; substantial structural modifications are required; access limitations make installation impractical; engineering constraints prevent construction; or the site is otherwise unsuitable.

- c. If a site is determined to be unsuitable, Altec may: offer an alternative design solution; permit the winner to nominate another eligible property; or redraw the Prize.
10. Approvals

 - b. If approvals are refused, Altec may: offer an alternative design; permit the winner to nominate another eligible property; or redraw the Prize.
 - c. Any costs arising from approval conditions, engineering requirements or site-specific requirements that cause the project value to exceed \$20,000 must be paid by the winner.
11. Exclusions
